

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE IS NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ELIGIBILITY: The SIDEPIECE Silo Dallas Backstage Pass Sweepstakes (the “Sweepstakes”) hosted by 1340 Manufacturing St. LLC (the “Sponsor”) is open to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry and that have access to the Internet at all times during the Sweepstakes Period and prize-award period unless otherwise specified by Sponsor. The drawing will be conducted by Sponsor, the judge of the Sweepstakes, whose decisions on all matters relating to the Sweepstakes shall be final and binding.
