The product manufactured by the company mentioned above is an ECF bleached pulp grade which is used for the manufacture of papers and boards for food packaging, of cooking and hot filter papers as well as of cigarette papers.

It was examined by us according to the

("Methods for testing papers and boards for food packaging", state of 2008, corresponding to the method no. 80.56 within the Official Collection of Test Methods according to § 64 of the Foodstuffs and Animal Feed Code - LFGB),

for the used raw materials and fabrication additives as well as for the release of substances which might endanger health.

regarding the heavy metal content.

Thus the ECF bleached pulp grade **ECF Eucalyptus Pulp** according to the sample material submitted may be used safely for the manufacture of papers and boards for food packaging, of cooking and hot filter papers as well as of cigarette papers. The finished products manufactured with it may stand in direct contact with dry, moist and fatty foodstuffs as far as the pulp grade mentioned above is concerned.

This certificate of compliance has a validity of 2 years and consists of 4 pages.
