# **Industrial Hemp Program Seed Acquisition Request Instructions**

## **Instructions**

#### **Seed Acquisition**

Industrial hemp "seed" includes planting seed and other vegetative propagating material (propagules). All seed must be pre-approved by LDAF prior to seed shipment into or within Louisiana. Licensees must submit a completed *Seed Acquisition Request* form, along with all required documentation to LDAF a minimum of two (2) weeks in advance of any proposed transfer of materials.

The seed source must be a licensed participant in a recognized program in the state of origin; i.e., an institute of higher education or an individual or company permitted, or licensed by another industrial hemp program being conducted under the authority of 7 U.S.C. § 5940.

It is the licensee's responsibility to ensure that the transfer or sale of any industrial hemp seed from another program complies with all applicable laws and policies in the originating state. LDAF has no authority to authorize or regulate industrial hemp materials physically located outside of Louisiana.

#### Compliance with THC Threshold

Licensees must use only seed that analysis has confirmed a THC concentration of 0.3% or less on a dry weight basis. Documentation, in the form of a Certificate of Analysis (COA) of measured THC levels of parent material must be submitted with this request to LDAF. The COA shall also include, at a minimum, the name, address, and telephone number of both the testing laboratory and the seed owner at the time of testing. Seed which has not been approved by LDAF through this process are prohibited in Louisiana. Any licensee found to be using seed not approved by LDAF may be subject to regulatory action, including any criminal liabilities that may apply.

#### **Completing the Form**

- Complete the form in its entirety;

This form must be received by LDAF a minimum of two (2) weeks in advance of proposed seed purchases.

#### **Required Documentation**

- Completed Seed Acquisition Request form
- Independent third-party laboratory COA that represents the mature parent material of each variety. Test results must also identify the seed owner at time of testing and variety/strain name.
- Phytosanitary documentation for international sourced seed.
