Any horse that you do not own or have on full loan with a written loan agreement. Costs for any non-emergency lifesaving surgical operation, MRI, scintigraphy, computerized (axial) tomography, thermography, myelography without our prior written consent. Any costs as a result of castration, vaccinations, preventative treatment, the removal of wolf teeth or vices/behavioral problems. Any costs for the destruction of your horse, the disposal of its body or any post mortem examination. Any costs for vet/complementary treatment your horse receives more than 12 months from the date the accidental external injury was sustained. The strain of tendons and ligaments. Illness. Any trade, business, profession or use of your horse for hire or reward. Any claim until we receive your horse's passport, other evidence of legal ownership or the loan agreement. Any costs if there is any other valid and collectible insurance available to you.



Are there any restrictions on cover?

- ! Your policy does not cover any pre-existing condition an accidental external injury caused by, related to, or resulting from an accidental external injury sustained before the start date of your membership.
- ! We will not pay the excess £135 per claim or the excess under any other insurance available to you.
- ! Endorsements may apply to your policy. These will be shown in your policy documents.
- The horse is only covered whilst you are an active member of the World Horse Welfare.



Where am I covered?

- The United Kingdom, the Republic of Ireland and at bases of Her Majesty's Forces overseas.
- ✓ Temporary cover elsewhere in the European Economic Area for up to 30 days in total during the period of membership.



What are my obligations?

- You must take care when answering any questions asked by ensuring that any information provided is accurate and complete.
- You must tell World Horse Welfare as soon as practicable if you become aware of any inaccuracies or changes in the information you have provided, whether happening before or during the period of membership.
- > You must take all precautions to prevent accidental external injury, theft, loss or damage.
- In the event of an accidental external injury you must as soon as is practicably possible employ a veterinary surgeon at your own expense and provide proper care and treatment.

- Contact SEIB Insurance Brokers should your horse require a surgical operation, MRI, scintigraphy, computerized (axial) tomography, thermography or myelography.
