

**ORDINANCE NO. 3565-21**

**AN ORDINANCE TO AMEND AND REVISE CHAPTER 126 "VEHICLES AND TRAFFIC" SPECIFICALLY 126-65 THEREIN ENTITLED "PENALTIES" OF THE BOROUGH CODE OF THE BOROUGH OF RUTHERFORD**

**WHEREAS** the Governing Body of the Borough of Rutherford believes it is in the best interest of the Borough to Amend and Revise §126-65.B entitled "Penalties" of the Borough Code of the Borough of Rutherford.

**BE IT ORDAINED** by the Mayor and Council of Rutherford, County of Bergen, State of New Jersey, as follows:

**SECTION 1.** §126-65 of the Borough Code of the Borough of Rutherford, entitled "Fees" is hereby amended to add the following revisions:

**126—65. Penalties**

B. The following specific penalties are hereby established for violations of the referenced sections:

- (1) Section 126-1 prohibited parking in designated areas: ~~\$45.~~ \$35.
- (2) Section 126-2 prohibited stopping or standing: ~~\$45.~~ \$35.
- (3) Section 126-3, fifteen-minute parking restriction: ~~\$45.~~ \$35.
- ~~(4) —\$35. Section 126-4, thirty-minute parking restriction: \$35.~~
- (4) Section 126-5, parking prohibited certain hours: ~~\$45~~ \$35
- (5) Section 126-7, two-hour parking limit: ~~\$45~~ \$35.
- ~~(6) —Section 126-6, one-hour parking limit: \$35.~~
- (6) Section 126-8, three-hour parking limit: ~~\$45~~ \$35.
- (7) Section 126-9, overnight parking prohibited (commercial areas 2:00 a.m. to 6:00 a.m.): ~~\$60.~~ \$50.
- (8) Sections 126-9.1 and 126-9.2, truck parking restricted (commercial MV in business district): \$100.
- (9) Section 126-10, emergency parking restriction: \$100.
- (10) Section 126-11, parking during snow emergencies: \$200
- (11) Section 126-14, parking by permit only: ~~\$60~~ \$50
- (12) Section 126-29, parking within markings required: \$50.

- (13) Section 126-32, metered overtime parking prohibited: ~~\$40~~ **\$20.**
- (14) Section 126-37, parking meter charges (overtime parking, specified streets 8:00 a.m. to 7:00 p.m.) **\$45.**
  - ~~(a) First offense: \$20.~~
  - ~~(b) Second and third offense: \$33.~~
  - ~~(c) Fourth to ninth offense: \$57.~~
  - ~~(d) Tenth or more offenses, per offense: \$157.~~
- (15) ~~Section~~ **Sections 126-51, and 126-53, left and right turn prohibitions: \$150**
- (16) Section 126-52, U-turn prohibitions: \$150.
- (17) Section 126-54, parking within bus stops prohibited: \$75.
- (18) Section 126-56, parking within loading zones prohibited: \$75.
- (19) Sections 126-60 and 126-61, truck weight limits: \$150.
- (20) Section 126-62, alternate side parking: ~~\$45~~ **\$35**
- (21) Section 126-68, lane reservation: \$150.
- (22) Section 126-69, handicapped parking restrictions: ~~\$250. as per state statute~~
- (23) Section 126-9.5, Public parking spaces for charging of electric vehicles: **\$45**
  - ~~(a) First offense: \$20.~~
  - ~~(b) Second and third offense: \$33.~~
  - ~~(c) Fourth to ninth offense: \$57.~~
  - ~~(d) Tenth or more offenses, per offense: \$157.~~
- (24) **Section 126-42, permit only parking zones: \$60.**
- (25) **Section 126-42.H, misuse, expired or counterfeit permit: \$100.**
- (26) **Section 126-58, angled Parking: \$45.**
- (27) **Section 126-59, repair of vehicle in the roadway: \$100.**

SECTION 2. All ordinances of the Borough of Rutherford, which are inconsistent with the provisions of this ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.


SECTION 4. All other provisions of §126 of the Code of the Borough of Rutherford are not further amended and remain in full force and effect.


The ordinance shall take effect immediately upon final passage.
