

## ORDINANCE 3581-21

### AN ORDINANCE TO AMEND AND REVISE CHAPTER 33 SECTION 24 "FIRE DEPARTMENT-UNIFORM ALLOWANCE" OF THE BOROUGH CODE OF THE BOROUGH OF RUTHERFORD

**WHEREAS** the Governing Body of the Borough of Rutherford believes it is in the best interest of the Borough to Amend and Revise Chapter 33-24 entitled "FIRE DEPARTMENT – UNIFORM ALLOWANCE" of the Borough Code of the Borough of Rutherford to reflect a reasonable increase in the clothing allowance of its firefighters and to provide for other allowances.

**BE IT ORDAINED** by the Mayor and Council of Rutherford, County of Bergen, State of New Jersey, as follows:

**SECTION 1.** Chapter 33 §24 of the Borough Code of the Borough of Rutherford, shall be entitled "FIRE DEPARTMENT – UNIFORM AND OTHER ALLOWANCES" and is hereby further amended to read as follows:

#### **§ 33-24 Uniform and other allowances.**

##### **A.**

On or before the first day of January of each year, the Borough of Rutherford shall pay a yearly sum of ~~\$800~~ **\$1,200** per active member in good standing for uniform allowance. The payment shall be made to the companies and distributed by the companies to the active members.

##### **B.**

On or before the first day of January of each year, the Borough of Rutherford shall pay a yearly sum in the same amount set forth for active members for each then living retired member on the roles of the companies. The payment shall be made to the companies and distributed by the companies to the retired members.

##### **C.**

On or before the first day of January of each year, the Borough of Rutherford shall pay a yearly sum of \$360 to each active special duty fire fighter in good standing who shall have performed not less than 50% of the fire duty calls occurring during the preceding year.

##### **D.**

There shall be no uniform allowance for auxiliary members of the Fire Department.

**E.** Additional allowances shall be paid annually to the following officers and in the following amounts:

**SECTION 2.** Effective date. This chapter shall take effect immediately for the calendar year 2021


