

**ORDINANCE NO. 3583-21**

**AN ORDINANCE TO AMEND AND SUPPLEMENT  
THE CODE OF THE BOROUGH OF RUTHERFORD, CHAPTER 126, SECTIONS 69A AND  
69C ENTITLED "DESIGNATION OF SPACES"**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Rutherford, County of Bergen, and State of New Jersey that Chapter 126, Section 69A and Section 69C of the Code of the Borough of Rutherford Entitled "Designation of spaces" shall be amended and that those portions of the Ordinance set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged:

**§ 126-69A**

**The restricted parking space located at:**

**Eastern Way West Commencing 314 feet from the southwest intersection of East Passaic Avenue and Eastern Way and running southerly for a distance of 22 feet is hereby repealed.**

**§ 126-69C**


**The following restricted parking space is hereby added:**

**This parking space is hereby solely dedicated for use by a vehicle bearing the disability placard No. P2361185, and any renewals or replacements thereof.**
