

ORDINANCE NO. 3622-22

AN ORDINANCE TO AMEND AND REVISE CHAPTER 126 "VEHICLES AND TRAFFIC" OF THE BOROUGH CODE OF THE BOROUGH OF RUTHERFORD

WHEREAS the Governing Body of the Borough of Rutherford believes it is in the best interest of the Borough to amend and revise §126 entitled "VEHICLES AND TRAFFIC" of the Borough Code to delete two handicapped parking spaces and to create two handicapped parking spaces and to amend Section 126-69A (Designation of Spaces) as set forth herein.

BE IT ORDAINED by the Mayor and Council of Rutherford, County of Bergen, State of New Jersey, as follows:

SECTION 1. §126-69A of the Borough Code of the Borough of Rutherford, entitled "Designation of Spaces" is hereby amended and revised to add and delete the following:

§126-69. A. Public street spaces (minimum length 22 feet each).

The following locations are deleted from the Ordinance:

| Name of Street | Side: | Location: |
|-----------------------|------------------|---|
| Ames Ave | South | Commencing 68 feet from the intersection of Ames Ave and Chestnut St and running westerly for a distance of 22 feet. |
| Ames Ave | South | Commencing 90 feet from the intersection of Ames Ave and Chestnut St and running westerly for a distance of 22 feet. |

The following locations are added to the ordinance:

| Name of Street | Side: | Location: |
|-----------------------|--------------|--|
| Ames Ave intersection | South | Commencing 125 feet from the southwest of Ames Ave and Chestnut St and running westerly for a distance of 22 feet. |
| Ames Ave intersection | South | Commencing 147 feet from the southwest of Ames Ave and Chestnut St and running westerly for a distance of 22 feet. |

SECTION 2. §126-5A-1 is hereby deleted in its entirety.

~~No vehicle shall be permitted to park, except in designated handicapped spaces, between the hours of 7:30 a.m. and 8:30 a.m. and between the hours of 1:30 p.m. and 3:30 p.m., on school days only, in the following designated areas of the following streets:~~

~~South side of Ames Avenue between Chestnut Street and Home Avenue.~~

SECTION 3. Section 126-5B is hereby amended to include:

- (10) Ames Avenue on the southerly side, commencing at a point 68 feet from the intersection of Ames Avenue with the southwest side of Chestnut Street and running westerly thereon for a distance of 57 feet.
- (11) Chestnut Street on the westerly side, commencing at a point 34 feet from the intersection of Chestnut Street with the southwest side of Ames Avenue and running southerly thereon for a distance of 53 feet.


SECTION 4. All ordinances of the Borough of Rutherford, which are inconsistent with the provisions of this ordinance, are hereby repealed to the extent of such inconsistency.




SECTION 6. All other provisions of §126 of the Code of the Borough of Rutherford are not further amended and remain in full force and effect.
