

ORDINANCE NO. 3664-23

AN ORDINANCE TO AMEND AND REVISE CHAPTER 126 “VEHICLES AND TRAFFIC” OF THE BOROUGH CODE OF THE BOROUGH OF RUTHERFORD

WHEREAS the Governing Body of the Borough of Rutherford believes it is in the best interest of the Borough to amend and revise §126 entitled “VEHICLES AND TRAFFIC” and in particular §126-62 entitled “Alternate Side Parking Designation” of the Borough Code to amend parking times on certain streets;

BE IT ORDAINED by the Mayor and Council of Rutherford, County of Bergen, State of New Jersey, as follows:

SECTION 1. §126-62 of the Borough Code of the Borough of Rutherford, entitled “Alternate Side Parking Designation” is hereby amended and revised as follows:

§126-62 Alternate Side Parking Designation

No vehicle shall be permitted to park between the hours of the days specified upon any of the streets or parts of streets described below:

E.

No person shall park a vehicle between the hours listed on Thursdays, prevailing time, on the following streets:

Hours: 12:00 noon and 3:00 p.m.

(e)

~~West side of Elm Street between Washington Avenue and Morse Avenue~~

(f)

East side of Wood Street between **Morse Avenue** ~~Washington Avenue~~ and Erie Avenue.

F.

No person shall park a vehicle between the hours listed on Fridays, prevailing time, on the following streets:

Hours: 12:00 noon and 3:00 p.m.

(e) Reserved

~~East side of Elm Street between Washington Avenue and Morse Avenue~~

(f)

West side of Wood Street between ~~Morse~~ Washington Avenue and Erie Avenue.

G.

No person shall park a vehicle between the hours listed on Wednesdays, prevailing time, on the following streets:

6:00 a.m. and 8:00 a.m.

(oo) East side of Wood Street between Washington Avenue and Morse Avenue

(pp) East Side of Elm Street between Washington Avenue and Morse Avenue.

H.

No person shall park a vehicle between the hours listed on Fridays, prevailing time, on the following streets:

6:00 a.m. and 8:00 a.m.

(oo) West side of Wood Street between Washington Avenue and Morse Avenue

(pp) West Side of Elm Street between Washington Avenue and Morse Avenue

SECTION 2. All ordinances of the Borough of Rutherford, which are inconsistent with the provisions of this ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.

SECTION 4. All other provisions of §126 of the Code of the Borough of Rutherford are not further amended and remain in full force and effect.

The ordinance shall take effect immediately upon final passage.
