Department News

- From the DPW -

The Department of Public Works is looking forward to resuming the normal spring operations. Our department takes a lot of pride in Rutherford's field conditions and it was sad to see them go unused for much of last year. Especially now that Diamonds 5 and 6 at Memorial Park have lighting, we're looking forward to resuming the usual care that residents are used to finding in their recreational facilities.

Additionally, I'd like to tell you about the **Rutherford Reforestation Program**. We take tree planting very seriously here and it's important that residents know that healthy Borough-owned trees are not removed unless they have been evaluated by DPW's tree expert, who is licensed by the International Society of Arbor Culture. This employee creates a forumula based on the diameter, species, age and health of the tree in order to issue a cost to the resident. Based on this knowledge, if the resident decides to proceed with the tree removal, they are required to compensate the Borough for removal. That money is placed in a fund dedicated solely to replenishing our tree inventory. The DPW has a goal of planting 300 trees this year. Healthy Borough trees will not be taken down unless a full evaluation is undertaken and a fee paid by the resident that ultimately funds the planting of multiple more trees.

As we get through the winter together, the DPW requests that you please park your car in the driveway, if you have one, when it snows. Occasionally residents will leave their car on the street during a snow emergency because they think snow will be plowed into their driveway, but removing as many cars from the roadways is crucial to maintaining clean roadways for all residents as well as emergency vehicles. RPD tickets cars left on snow emergency streets in order to enforce this.

I'd like to also mention how proud I am that Rutherford's DPW maintains street cleaning 12 months a year, when many other municpalities do not. Unless a major storm is expected, we continue all operations as normal all year long. Thank you for your continued cooperation.

Chief Russo brought to my attention a letter he received pertaining to the actions of four of his officers. While it is not uncommon for him to receive letters of thanks or accommodation, this specific letter was unique as it was from a defense attorney who felt the need to acknowledge the officers' actions after reviewing Body Worn Camera footage which was part of a legal case.

Without reading the letter verbatim, I will share the first and last sentences from the attorney since they reflect his sentiment..."The level of professionalism, courtesy and kindness displayed by the officers of the Rutherford Police Department is far more than noteworthy, it is commendable"; "Quite honestly, other police departments could benefit by using the video in the matter as a training tool."

Chief Russo stated he was very proud of his officers, although not surprised. He stated these actions are indeed commendable, but they represent a majority of our daily interactions and are a true testament to the quality of the personnel employed here at the Rutherford Police Department. He also thanked the attorney for submitting the letter because most of the actions of his officers are very autonomous by the nature of this profession and are not recognized. This is yet another great example of the benefits of body worn cameras.
