### From the Desk of Mayor Frank Nunziato

At Tuesday's meeting, the Council voted in favor of designation M&M at Rutherford Urban Renewal Company, LLC the redeveloper of record for the the redevelopment area known as Agnew A. The Council also voted to authorize the execution of a financial agreement by and between the Borough and M&M. The financial agreement can be found on the Borough website under Mayor and Council agendas. More information regarding the Boroughs obligation to meet affordable housing requirements can be found under the Land Use & Redevelopment page on the Borough home page.

The ordinance authorizing a financial agreement between the Borough and M&M passed on first reading and will be up for a second reading at the October 25th Mayor and Council meeting. At that time the public will have two opportunites to speak on it before it is voted on.

I'd like to announce that the committee, board and commission application process has reopened and we will be accepting applications from now through November 15th. We are especially looking for residents willing to lend their specific talent to a committee whose mission is within your area of expertise. This kind of a volunteering is a great way to strengthen our community.

Having a diverse group of residents willing to serve benefits our committees, boards or commissions since it allows professionals at many levels to weigh in on issues on progreams that pertain to our residents. Please note that boards and commissions are governed by by-laws and have a limited number of seats available each year. The application can be found on the home page of the Borough website along with descriptions of each committee, board and commission.

Finally, I'd like to thank everyone who came out to our first ever Rutherford Day on October 2nd, as well as our staff from Recreation and DPW who helped make it possible. It was a great community event and what I hope will be the first of many Rutherford Days to come!

### **Council Reports**

#### **Council President Mark Goldsack**

On Monday the Council both designated M&M at Rutherford Urban Renewal Company, LLC as the redeveloper of the redevelopment area known as Agnew Place Area A and also passed on first reading an ordinance authorizing the execution of a financial agreement by and between the Borough and M&M.

This project has been the subject of discussion during numerous meetings over the course of two administrations. The public has had numerous opportunities to share their concerns about this project over the course of many years.

We have heard those concerns and believe we have come to an agreement that will not only start the process or finalizing a project in an area of our community that was highlighted in our master plan as a prime location for redevelopment, but also start the process of putting a concrete plan in place to begin building our much needed affordable housing obligations by 2025.

I believe this project will be an asset to our community from an economic standpoint, bringing additional foot traffic to our business community, but also from a tax revenue standpoint. Keep in mind that the Borough receives 95% of the revenue from PILOT payments, with the remainder going to the county. Also keep in mind that the land itself is still taxed conventionally, meaning the schools receive their usual allocation of their tax revenue.

With that in mind I know that Mayor Nunziato has committed to having discussions with Superintendent Hurley and the Board of Education about the possibility of sharing in PILOT payments if the circumstances call for it.

I look forward to working with Mayor Nunziato and my council colleagues as we continue to discuss and develop this project to ensure that all concerns are addressed and succeed in executing a project that is beneficial for Rutherford now and in the future.

### Affordable Housing and Working Toward the Borough's Obligation of 2025

On Tuesday evening, the Mayor and Council took another step toward satisfying our Fair Housing Act responsibility formerly known as the Council on Affordable Housing or COAH. Per the decision rendered by the NJ Supreme court in 1975 (South Burlington County NAACP v. Twp of Mt. Laurel, 67 NJ 151 (1975)), and subsequently in 1983 (South Burlington County NAACP v Mt. Laurel Twp., 92 N.J. 158 (1983)), municipalities such as Rutherford, are required to provide a fair share of affordable housing when development projects happen. The subsequent decision of 1983 addressed a consequential action to those municipalities that remained non-compliant with creating affordable housing known as a "builders remedy". Per our Borough website, "In September 2019 a settlement with the FSHC (Fair Share Housing Center) was reached that will protect the borough until July 1, 2025. It establishes certain benchmarks and goals for the borough's development of affordable housing through its ordinances, administrative procedures, and redevelopment and planning" (www.rutherfordboro.nj/landuseanddevelopment/ affordablehousing). As a Borough, the governing body must make progress toward satisfying the negotiated number of units within our borders to the best of our ability to satisfy the obligation before or by 2025. We took the first step of continued negotiations this week. I thank my fellow elected colleagues who understand the magnitude of this responsibility, and equally the severe penalties for non-compliance, that voted to support the redevelopment agreement for the Agnew Place project
