From the desk of Mayor Frank Nunziato

I'd like to start by addressing some of the items discussed at Tuesday's Mayor and Council meeting.

I have received feedback regarding the proposed temporary parking for Borough employees around Lincoln Park. I'd like you to know that after consideration, we will not pursue that option and will instead seek to issue employees parking placards allowing them to park in the same area while allowing regular use of the metered areas for the general public.

The employee parking was always intended to be temporary as the construction set to begin on the new police station would displace our current parking lot. Once construction ends, there will once again be parking available to employees on Borough Hall property. However, I certainly understand the concerns of the nearby businesses and residents and therefore will advise the Governing Body to not pursue that option. I will bring you updates on the building of the police station as they become available.

The 2020 Municipal Budget was officially passed. There is a tremendous amount of work that goes into crafting a municpal budget, and I'd like Borough Chief Financial Officer Gordon Stelter, Business Administrator Robert Kakoleski and my colleagues on the Governing Body for all their efforts.



Finance

- **Resolution No. 91** Amending the Municipal Budget Passed This resolution amends the 2020 municipal budget to include the following three grants totaling \$216,000; NJSEA Arbor Day Tree Grant (\$1,000), 2020 Census Grant (\$5,000), and NJDOT Transit Village Grant (\$210,000).
- Resolution No. 92 Adopting the 2020 Municipal Budget Passed This resolution officially adopts the 2020 Municipal Budget. I'd like to thank our CFO Gordon Stelter and our Business Administrator Robert Kakoleski for all of their hard work and dedication in crafting a budget that ensures that we will continue to deliver excellent services to our residents and also provides much needed investment in those assets that will allow us to deliver those services in the future. I'd like to also thank my Finance committee co-chair Councilwoman Stephanie McGowan, Mayor Nunziato and Council President Mullahey for all of their help and guidance throughout this process. Thank you to my all of council colleagues and especially all of our department heads who were faced with an unprecedented situation, had made difficult decisions and never lost sight of our collective goal of serving the residents of the Borough of Rutherford.
- Resolution No. 93 Police Building Project Labor Agreement Passed This authorizes the Borough to enter into a pre-hire collective bargaining agreement with various labor organizations for the construction of the police building. These agreements are beneficial for projects in excess of \$5 million dollars as they set the terms and conditions of employment and ultimately help ensure more efficient project management.
- **Resolution No. 94** Authorizes the Preparation and Mailing of Estimated Tax Bills The State of New Jersey has not passed a FY2020 budget. As a result, the Bergen County Board of Taxation is unable to certify the Borough's tax rate however, in lieu of sending residents late tax bills, the law allows the Borough CFO and Tax Collector to compute estimates taxes for the purposes of mailing the bills in a timely manner.

Community Events

Cancelling Labor Day - Due to the current health crisis, a resolution was passed cancelling the Labor Day Street Fair. While we recognize that this decision is disappointing, and while we also recognize we, as a community, have done a tremendous job making sacrifices and doing what is necessary to combat COVID-19, we believe cancelling this event is the best course of action to protect the health, safety and welfare of our residents.

In honor of Earth Day 2020 and the Rutherford Green Team's current work renewing the Borough's Sustainable Jersey Certification status, the Green Team has made a goal getting borough residents to participate in some challenges that collectively make an impact on the sustainability of our community. The Green Team has created 9 challenges to improve the sustainability in our community.

WHY?

Because the markets for recyclable materials (MRF) have fallen off in recent years, it is essential for borough residents to carefully scrutinize what can and what cannot recycle under the current system. It's not enough to go by intuition. Some plastic items cannot recycle even if they have the right number, but on the other hand, paper milk cartons, which didn't use to be recyclable, are now accepted by our MRF.
