From the Desk of Acting Mayor Mark Goldsack

At Monday's meeting, the Council voted 4-1 to approve a redevelopment plan for the Williams Center. While the Council appreciated the thoughtful recommendations made by the Planning Board, the Council believes that the recommendations would have made the plan unreasonably restrictive. In light of the upcoming August 19th auction by the property's owner, Bergen County, the Council believes the best course of action is to put a plan in place that gives the Borough the control offered by the redevelopment process, and the flexibility offered by a plan that provides alternate development opportunities.

Although as Acting Mayor I was unable to vote on this issue, I do agree with its outcome.

I understand everyone's passion regarding the Williams Center, and specifically the Newman Theater, which many want to see preserved and restored to its former glory. For years, residents and elected officials alike have taken every opportunity possible to speak with potential investors and theater professionals, but as of now none of these conversations have borne any fruit.

The reality is there is not a legal mechanism afforded to the Borough that physically protects the theater. I support Councilman Mullahey's approach of adopting a plan that allows the Borough flexibility to negotiate. The more restrictions we put into the plan, the less we're afforded the opportunity to negotiate. We can insist that the Newman Theater is preserved in a redevelopment plan, but it will have no legal teeth when a buyer purchases it from the county. A less restrictive redevelopment plan, and one that incentivizes buyers to preserve and work around the Newman Theater, gives the Borough the flexibility we need to negotiate a plan that will not only support our arts community, but also provide a boost to our local economy.

It is entirely possible that a buyer wanting to refurbish and maintain the Newman Theater will still come forward. This plan does not prohibit that. The plan does, however, offer options to a potential buyer who may have creative ways to establish a thriving arts space that is economically viable. The Williams Center is an important part of the downtown, which is exactly why it's our duty to keep all options on the table that preserve its viability for generations to come.




3rd Quarter "Estimated" Tax Bills will be mailed the week of June 21st. 3rd Quarter taxes will be due between August 1st and August 10th.

Williams Center:

I'd like to address my vote in support of the original redevelopment plan of the Williams Center as compared to the redevelopment recommendations put forth by the Planning Board. I have spent countless hours reviewing the plans submitted by Neglia Engineering as well as the planning board's recommendations and minutes from the public workshops. I have listened to many residents voicing their opinions and concerns.

My decision did not come quickly. I realize the Williams Center fate draws upon many opinions, factors and realities. I hear the residents loud and clear in support of having a home for the arts in our downtown area and preserving as much of the building as possible.

The question is: How is this achievable when we do not own the facility? Having a redevelopment plan in place with restrictions gives the residents a chance of hope. Having a performing arts venue in the heart of our business district makes sense. Our local downtown businesses will benefit from residents and visitors attending a nightout at the Williams Center.

I had to take a step back from all of the emotional feelings and focus on what would be the best negotiating redevelopment plans put forth to benefit the residents of Rutherford. Throughout my career of negotiating multimillion dollar contracts I have learned it is best to come to the table with many options. Having too few options at the beginning of a negotiation may leave you short-handed in the end. While I am grateful for all the hard work the Planning Board put into serving up their recommendations, I feel the plan is too limiting in trying to find a suitor.

Other pressing questions I had were: What happens if the county auction results in no buyer? Where do we go now? What will the county do? What happens to our downtown area and a chance of having a performing arts center? Because of these questions, and knowing our residents want and deserve a thriving downtown with a desire for an anchor destination for the arts, I have made my decision to support the original redevelopment plan.

Thoughts on the William Center

The William Center has been at the center of debate for many years, even before I joined the Council in 2015. Personally, I had pitched many ideas about a variety of uses and tried to express those visions with potential investors. Sadly, the outcome was always the same: great idea, but the cost outweighed the benefit from a business perspective.

Now, the time has come where the property owners have decided to go forward with auctioning the property. After taking the many positions presented and guidance given into consideration, I believe that a less restrictive ordinance enables the Mayor and Council to have greater negotiating power on behalf of the residents we were elected to serve. I do think that our fiduciary responsibility is about making the hard decisions and doing the due diligence necessary to protect and represent the best interest of our 18,000 plus residents.

Further, we will have our professionals, who are hired to serve on behalf of the Borough, utilize their expertise in land use, regulations, and contracts to guide our decisions. Since we know the date for auction is quickly approaching, it is time for us to move this ordinance forward and prepare for the vision of what this important space can and should be once ownership is transferred.

I would be remiss if I did not express my appreciation to the WCW Board for their continued advocacy, the appointed group of citizens that provided feedback appointed by the former administration, our Borough Planning Board who provided thoughts and guidance for consideration and thank our residents for bringing their passion and requests forward. I would also express my sincerest gratitude for my Council colleague, Tom Mullahey, for holding public town halls to garner resident feedback and for providing a tremendous amount of information and support through this challenging decision process for the Mayor and Council.

Two years ago, I asked for the liaison assignment to the Williams Center. Two others before me had also held that liaison assignment. As liaison, I helped create a Williams Center committee with arts professionals, business owners and residents. Together we held two meetings where we collected public input. At these meetings, I repeatedly committed to taking public input and weighing it along with the options proposed by our hired professionals for a viable Williams Center going forward.

I fully expected and welcomed a passionate response from the residents about this redevelopment plan on Monday. What I didn't expect was being accused of not taking public input. I have always been transparent in saying that in order to maintain a revitalized arts center, there has to be an option for development that would increase any buyer's confidence in future profitability.

Members of the Williams Center committee did an excellent job over the years. I've attended their events and they've done as good a job as anyone to raise awareness. I've talked with individuals and groups that might be able to rehab the theater, as have my colleagues and members of the community. It always comes down to the same pattern: a lot of great ideas are discussed, but after requesting a proposal and proof of funds from the interested party, the conversation ends.

38 residents spoke at Monday's meeting. They basically all agreed that preserving the Newman Theater as-is should be a non-negotiable component of any redevelopment plan. What they didn't agree on was how to do it. Or what other components to the Williams Center could best serve Rutherford in the future.

We heard people say how they don't want Rutherford to be urban like Jersey City, followed by speakers who praised Jersey City's ability to promote the arts. I've done my research in Jersey City, where unlike Rutherford, the city owned the theater and had the budgetary resources to support the theater for 20+ years while they awaited an investor. Even under those circumstances, serious donors didn't come forward to support large arts projects until they knew there was a local population density that would guarantee a return on their investment.

After years of ideas, we are at the point where this project needs specifics. And while we may ultimately disagree, I would hope you can appreciate the complicated nature of creating a redevelopment plan that marries often contradictory public opinions with the data driven input of our hired professionals. I do believe this redevelopment plan comes as close to accomplishing that as possible, and I look forward to being able to negotiate the best for Rutherford with whoever the County sells the property to.


- EPS only: this is the kind of styrofoam used in packaging, shipping, and insulation
