From the Desk of Acting Mayor Mark Goldsack

In light of discussion surrounding the Parker II redevelopment plan at Monday's meeting, I'd like to discuss the process by which all redevelopment plans happen. The process is designed to give the public ample opportunity to express their concerns. We currently have the Parker Phase II redevelopment plan for the Mayor and Council for consideration. The public has expressed to us different concerns. The plan, as introduced, is a draft plan until it is adopted by the Mayor and Council. It was up for first reading on Monday, and the council voted in favor of it. It will be up for second reading at our next meeting at which time the public will have another opportunity to speak to it. If it is adopted, then the redeveloper can submit a site plan for review to the Planning Board. At that time, a lot of the concerns that have been raised, such as required parking and set backs can be addressed and we can address them in the redeveloper's agreement.

I think history has shown that this Mayor and Council does in fact listen to the concerns of the community, and last year's vote to not allow additional height to the Agnew Place redevelopment plan proves that. Sometimes we may not agree with everything asserted by the public. But we do factor what is said in the public's ample opportunities to speak into our decision making process. I can only speak for myself, but I do want our residents to know that I personally try to make a determination about what redevelopment project to see whether it will benefit or make a difference for our town on a case by case basis. One does not set a precedent for another when it comes to how I cast my vote, when I have the opportunity to vote.

Regarding the Williams Center, the Borough is currently in discussions with interested parties that are providing proof of reliable financial backing. These discussions include what the developer's goals are for the property as a whole and the Newman Theater specifically. We are doing the best we can to make sure something comes to fruition and that the developer has the proper financing to take on such a heavy lift. I am simultaneously keeping lines of communication open with the County so they know what to expect from us. I want to thank Councilman Mullahey for all the hard work he's put into this during his years as liaison to the Williams Center as well as my other Council colleagues.

Cannabis Ordinance: As many of you may have noted recently, the mayor & council have joined in Senator Paul Sarlo's effort to prohibit Class 5 & 6 cannabis license types (Retail & Delivery) in southern Bergen county.

On Monday, July 12th, the mayor & council voted on a first-reading of an ordinance which would allow for the other 4 available cannabis license types within the state of NJ:

Class 1 Cannabis Cultivation License.

Class 2 Cannabis Manufacturer License.

Class 3 Cannabis Wholesaler License.

Class 4 Cannabis Distributor License.

Further, the ordinance restricts Class 1-4 licenses to areas and land east of Rte. 17.

Collectively, we have done exhaustive research during this process to craft an ordinance which will benefit and protect Rutherford for years to come should a state sanctioned company decide to approach us with their operating plans. As stated during Monday's meeting, the Borough of Rutherford will be competing with the other 564 municipalities for businesses such as these and we will continue to execute our due diligence in order to bring the appropriate business into our community.

I also want to thank my colleagues for listening to the research, facts and science behind this effort while avoiding the pitfalls of stereotype and stigma surrounding this industry.

As always, we are actively pursuing ways to generate revenue for the Borough without raising taxes. This is an opportunity ripe for our area and we look forward beginning the next phase of the process later this year.
