During April, the Department generated 1 use of force report. This report was associated with a mental health related call for service. We also generated 1 ARRIVE Together mental health referral through our Benchmark system.

At month's end, the Department had generated 8,099 CAD/RMS entries with 1,797 coming during April.

Patrol wrote **1,217 summonses** during the month; the breakdown of all summonses is:

- 109 moving violations
- 1,090 parking violations
- 18 local ordinances

827 of those summonses were issued by the Traffic Bureau.
