During February, the Department generated 2 use of force reports. Both were associated with the same individual. We also generated 2 ARRIVE Together mental health referrals through our Benchmark system.

At month's end, the Department had generated 4,536 CAD/RMS entries with 2,207 coming during February.

Patrol wrote 1,481 summonses during the month; the breakdown of all summonses is:

- 188 moving violations
- 1269 parking violations
- 24 local ordinances

810 of those summonses were issued by the Traffic Bureau.
