Councilman Guzman,

July 2024 saw 9 total arrests. (9 Adult)

- 2 – D.W.I.
- 2 – Simple Assault
- 2 – Outstanding ACS Warrant from other Jurisdictions
- 1 – Aggravated Assault
- 1 – Harassment
- 1 – Criminal Mischief

There were no juveniles arrested.
