During March, the Department generated 2 use of force reports. Both were associated with the same individual and were mental health related. We also generated 2 ARRIVE Together mental health referrals through our Benchmark system.

At month's end, the Department had generated 6,300 CAD/RMS entries with 1,942 coming during March.

Patrol wrote 1,289 summonses during the month; the breakdown of all summonses is:

- 138 moving violations
- 1,141 parking violations
- 10 local ordinances

821 of those summonses were issued by the Traffic Bureau.
