#### Batch Processing

- When to use it: Perfect for internal systems that lack real-time APIs or when you need to integrate large volumes of data reliably.
- How it works: Data is shared via files on a regular schedule (e.g., daily or weekly) and then ingested into the CDP. This ensures that even without direct API access, your data can be consistently and reliably integrated.
