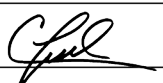

THE WELLNESS CENTER, PROVIDES IMMEDIATE SUICIDE-SPECIFIC CARE TO VETERANS AND SERVICE MEMBERS IN ALL 50 STATES AND WASHINGTON, D.C., THROUGH A 24/7 CALL CENTER, EVIDENCE-BASED TREATMENT DELIVERED VIA TELE-HEALTH WITH CLINICALLY TRAINED WELLNESS COORDINATORS, AND CONNECTION TO OUR TEAM OF RESOURCE, REFERRAL AND BENEFITS COORDINATORS. IN 2023 (JAN TO MARCH), WE DELIVERED MORE THAN 3,000 HOURS OF CARE TO MORE THAN 600 CLIENTS.
