WHAT COOKIES DO WE USE?

Currently there are three types of cookies that we use:

- **Necessary cookies** are essential in order for the website to run properly and in order that we can comply with legal obligations such as our security obligations under data protection law. - **Performance Cookies** collect information about things like how many people visit our website, what parts of the website people look at and how many new visitors we have to the website. - **Advertisement Cookies** monitor which pages visitors use. The purpose of these cookies to show you relevant ads on the web.
