### Future tense in Sanskrit

**Objective**: To understand the use of Future tense in Sanskrit

Concept A: Future-tense in Sanskrit is called as 'Lang Lakaara'

लृट्लकार / Lrut-lakaara (Future Tense): लृट्लकार (Lrut-lakaara) represents verb-forms in future tense (भविश्य/ Bhavishyakaal). So, while forming a sentence which is in future tense, the verb (क्रिया / kriaa) has to be in लृट्लकार (lang-lakaara).

Future tense is used to denote a supposition/condition that will happen in the future. The action has not taken place yet.

Examples: I go to school : present tense

I will go to school: future tense

I read a book: present tense
I will read a book: Future tense

In Sanskrit, we have 3 numbers and 3 persons.

Singular is called as Ekavachana Dual is called as Dwivachana Plural is called as Bahuvachana

Let us understand 3 persons:

1st person is called as Uttama Purusha

2nd person is called as Madhyama Purusha

3rd person is called as Prathama Purusha

**Concept B**: Let us understand more about future tense in Sanskrit:

The endings of future tense are similar to present tense except for some additions. These additions are:

Sya (स्य) Kshya (क्य) Shya (ष्य)
