THESE RANGE FROM PERMANENT SUPPORTIVE HOUSING FOR OUR MOST INDEPENDENT CLIENTS, TO LICENSED CARE FACILITIES WITH 24/7 STAFFING FOR BOTH ADULTS AND YOUTH. IN ADDITION, WE PROVIDE SEVERAL HOUSING OPTIONS FOR OUR HOMELESS POPULATION, WITH A RECENT FOCUS ON CHRONICALLY HOMELESS INDIVIDUALS. WE ALSO PROVIDE LOW INCOME HOUSING. ALTOGETHER, WE HOUSE OVER 300 CLIENTS ANNUALLY.
