Vinification

Fruit was harvested and arrived by daybreak; clones kept separate; 25% to 50% whole clusters; 3-7% of Roussanne incorporated as traditional co-ferment for deeper color and floral lift; cold soak 5-6 days; native fermentation; punched down 1-3 times daily; 14-16 days on skins; gently basket pressed; transferred by gravity to French oak barrels; 30-45% new oak; aged 11 months on lees; gentle filtration and fining prior to bottling.

This is a multi clone expression of our singular site giving a complete look at the breadth of our clones. The combination of soils and climate allow each clone to express its own unique characteristics to give a wine of complexity, seamlessness and breadth of expression.
