The label artwork, by David Berkvam, recognizes that the property was historically farmed as a cherry orchard and is now, thanks to Mark's provision of birdhouses, home to the beautiful bluebird.

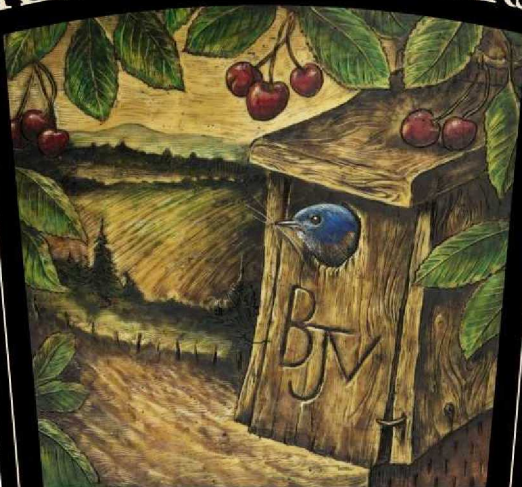
