In 1995, Ridge acquired the western half of Lytton Springs Vineyard, and made syrah from a small block of existing vines. Impressed with the results, we planted more syrah, and a few acres each of grenache and mataro (mourvèdre). This is our first wine combining all three southern Rhône-style varietals. Rich and full, it will be at its best over the next five to seven years. JO (8/15)
