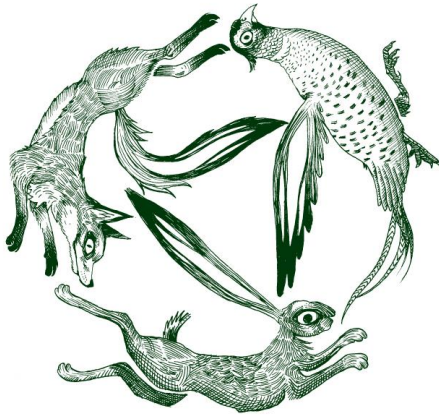

An expressive cognac from a fine but long-neglected grape - the Folle Blanche. The attack is direct and invigorating. The body is rounded and polished. Intense and complex fruit aromas are counterbalanced by subtle wood notes in the finish.

Protected distillation: non-chill filtered and made without additives to safeguard the authenticity and integrity of our eaux-de-vie.

Varying the proportion of the fin lees in the wines we distill allows us to modify the character of our cognacs.
