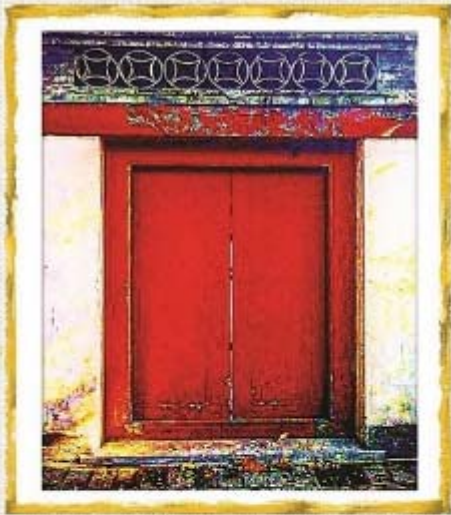

We begin our winery with two separate lots of really special wines that we purchased and completed for Secret Door Winery.

It is likely this will be the only time we create a wine using this method (let alone 2 wines). We can not by contract disclose the source details of this wine but we hope it is sufficient to say it was the two greatest wines available for purchase we have ever tasted.

We have given the wine an additional time in small French oak barrels and bottled the 2 lots separately because they seemed to show best that way. Lot: Secret 1Z is a total production of 250 cases of wine. The more brassy of the two 2014's Secret 1Z needs another year or two to be its best but has all the components for greatness.
