Half of this wine was barrel fermented and aged on the lees, the other half was Stainless steel fermented and aged for 9 months in French Oak barrels. This is a classic Chardonnay with typical aromas of ripe apples, pears, pineapple, hint of butterscotch and slight toasty oak. Balanced acidity leads to a long, juicy finish. Cheers.
