Vineyard: Old vine Malbec in Perdriel, Mendoza, at an altitude of 3,100 feet. The vines were planted in 1910, are more than 90 years old! Yield per plant was less than one pound of grapes. (1/3 of a bottle of wine)
Harvest: Manual, on March 28, 2003
Fermentation and Aging: Primary fermentation was performed in a small tanks. The wine underwent malolactic fermentation in new French oak barrels, where it was then aged for 13 months.
Bottling: On May 22, 2004, unfiltered to ensure aromatic integrity. Therefore, this wine will show deposits after some cellaring time. We recommend decanting an hour before drinking.
Analysis: Alc. 13.5%, PH 3.5, TA 5.95, VA 0.64, Total SO2 44
