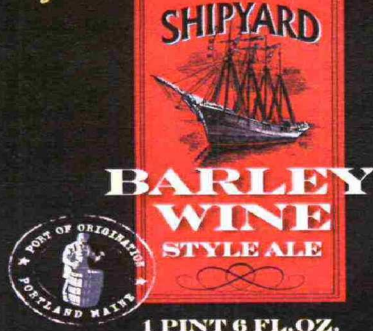

Pugsley's Signature Series is named after Shipyard Brewing Company's master brewer, Alan Pugsley. Alan is from England where he worked with Peter Austin at the world-famous Ringwood Brewery before moving to the United States in 1986. **Barley Wine Style Ale** is brewed in the true English tradition. This is a big beer made with six different malts (Pale Ale, Crystal, Caramunich, Wheat, Chocolate and Roasted Barley) and balanced with a very full hop charge of Summit, Challenger and Fuggles hops. It is a deep reddish brown color with a complex fruity nose, a very full body, and an interesting balance between grains and hops which ends with a pleasing dry taste. To fully experience all the flavours, this ale is best enjoyed at 55 degrees Fahrenheit.
