The grapes for our Cool Climate SYRAH come from the Dutton – Cherry Ridge Vineyard, located in the Green Valley of Russian River Valley. The cool climate is just temperate enough to ripen Syrah, which yields a rounded palate of berry fruit and lots of spice, and is highlighted by bright acidity and silky tannins. This wine is enjoyable now but will age beautifully for five to eight years. The Dutton family has been working the land in Sonoma County since the 1880s and today they sustainably farm about 850 acres in the Green Valley of Russian River Valley AVA.
