This 1865 wine honors Vitis San Pedro's founding year. It's crafted from carefully selected grapes from the Leyda Valley. The Las Gaviotas Vineyard is located just 4 km (2.5 mi) from the Pacific Ocean, in a mainly granitic marine terrace, where the ocean's influence translates into a wine with strong, expressive character, outstanding salinity, and freshness. It's marked by aromas of citrus peel, grapefruit, passion fruit, with hints of green pepper and white asparagus. The palate is fruity with crisp acidity, giving way to a juicy finish. It's balanced, elegant, and precision shines through in every detail.

De aromas cítricos a pomelo, fruta de la pasión, con notas a pimienta verde y espárrago blanco. Fruta al paladar, con una clara acidez que le da paso a un jugoso final. Un vino equilibrado y elegante, cuya precisión brilla en cada detalle.
