During World War II, an airbase was established at the foothills of the Pattlesnake Mountains. After the war, it was sold to the Miller family. For four generations, the family has farmed the surrounding area, using the old airbase as their farm headquarters. Wine grapes were planted at "Airfield" in 1968, and the family has been perfecting its craft ever since.

WINEMAKER'S NOTES: Well balanced with impressive acidity, this slightly sweet Riesling offers a bouquet of citrus and apple with a touch of minerality. It begs for Asian inspired foods, oysters, shellfish, and salads.
