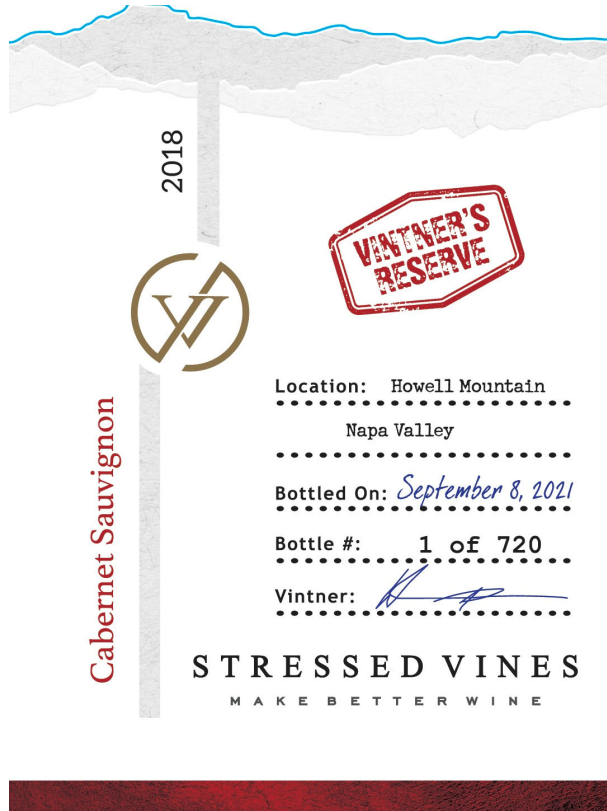

The wine has a wonderful dark inky purple color with notes of licorice, black currant and blackberry fruits as well as the signature elements of smoked meats and leather. On the palate the wine shows a nuanced richness with the perfect balance of tannins and just the right hint of oak. Crafted from clones 337 and 15 and then rested in new French Oak barrels for 34 months.
