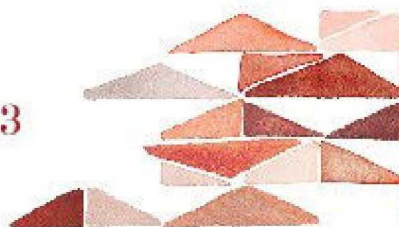

The resulting wine was the reward of those efforts and used to celebrate harmony.

A vibrant, elegant and intense wine with delicate notes of strawberries and raspberries, along with notes of sweet vanilla and a touch of nutmeg.

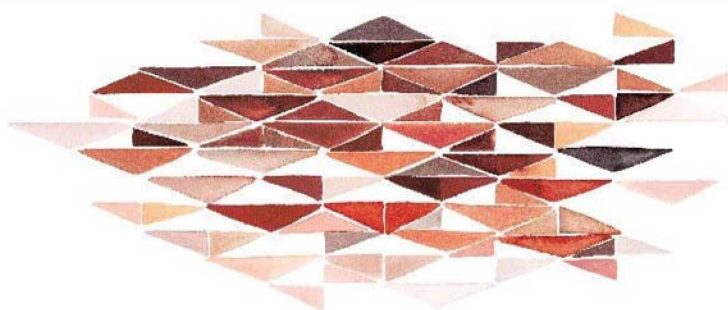
