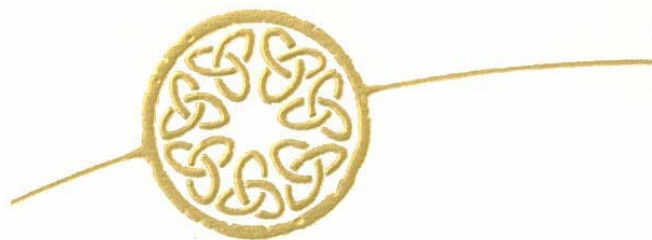

Along with my father, Vicky and I founded Seven Hills Winery in 1988. From that first vintage, my goal has been to craft intensely structured, balanced wines that express their vineyard origin.

In the tradition of the famous whites of Bordeaux, our Sauvignon Blanc is partially barrel fermented and blended with a small amount of Semillon for additional richness and depth. The wine shows pineapple, citrus zest, golden fig, fresh herbs, and floral aromas. It is lush and mouth-filling, with a crisp fruitful finish.
