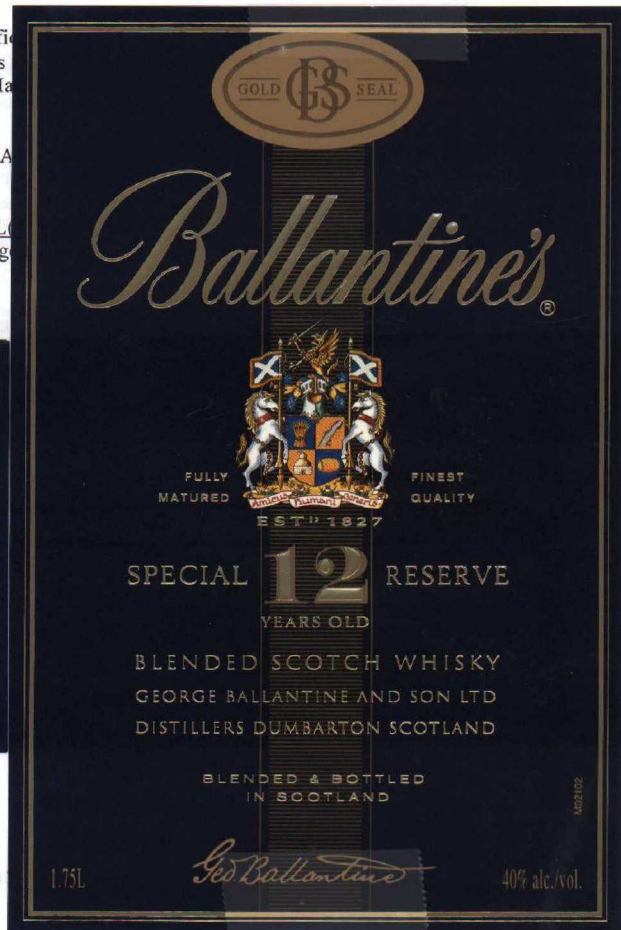

2. Copy of Alcohol, Tobacco & Firearms (BATF) Certificate.
3. Sample of product (in container with labels affixed as shown).
4. Proper fee. (\$25.00 for each size, brand and class). Mail to the Texas Alcoholic Beverage Commission.
5. One brand and class per application.
6. In this order staple application, BATF Certificate of Approval and documents in the upper left hand corner.
