Vinification

Each Pinot Noir clone was hand-harvested at night and arrived at the winery by daybreak. The fruit was hand sorted and fermented individually separated by clone. 6 days cold soak, gentle punch downs 1-3 times daily, 14-20 days on skins & gently basket pressed. Gravity fed to French oak barrels (52% new). Aged 16 months on lees, gently fined, bottled unfiltered.

Site

The Annadel Gap Vineyard is a special place. Located in the narrow windswept corridor of the northern Sonoma Valley, our site is characterized by thick morning fog and strong afternoon winds. Alluvial, glacial, and sedimentary influences create a wide array of soil types. Ideal growing conditions, varied soils, and our minimal-impact farming methods yield precise, balanced fruit.
