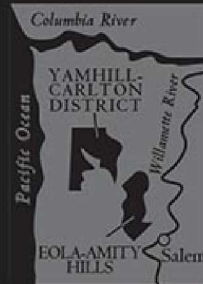

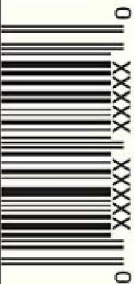
This wine, sourced from select vineyards in the Willamette Valley, pays respect to those original settlers who first toiled and cherished these lands.
