Origin Own vineyards in the Palquibudis district (Chilo Chico Estate) Curico Valley, Entre Cordilleras.

Variety 60% Malbec and 40% Merlot

Harvest By hand; the Merlot was picked at the beginning of April, while the Malbec was harvested towards the end of April.

Aging Six months in French oak barrels.

Color Dark ruby red with violet hues.

Aroma Ripe berries, with notes of raisins and cassia. Notes of smoke, toast and damp earth, together with pleasant floral and vanilla aromas. There is good integration between the fruit and the oak.

Flavor Concentrated, ripe, spicy, toasty, complex and well-balanced. Smooth, round tannins. With a pleasant long finish.
