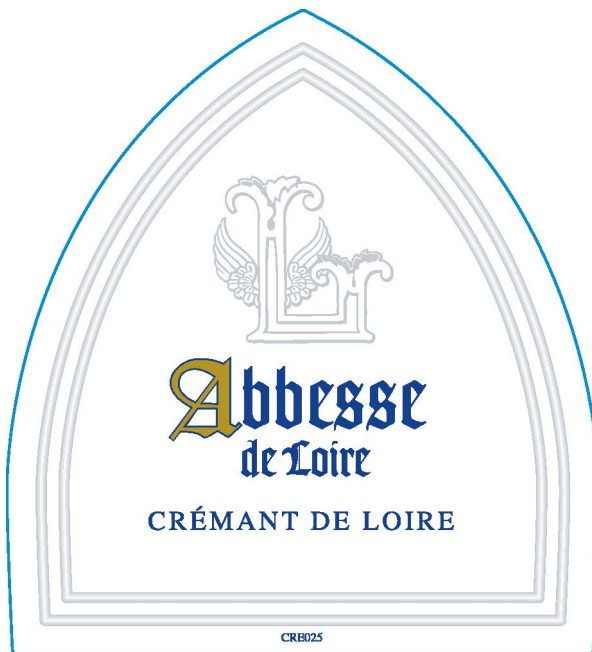

Her motif, the L ailé (winged L) can be found throughout the building in carved marble panels and decorative floor tiles. We crafted our Crémant rosé from the region's classic red grapes using the same méthode traditionnelle as the finest French sparkling wines. After 12 months ageing in the bottle, our rosé is a beautiful pale salmon pink, with a fine lively mousse and complex summer berry fruit notes.
