This wine is crafted from our original block of Chenin Blanc, now thirty-six years old. It was the first white wine I made at Pheasant Ridge, and I am happy to do so once again in recognition of the quality of this noble grape of France. The wine expresses the terroir for which we selected the vineyard site. Its crisp acidity and flavors of pear and lemon are a result of the deep sandy soil, intense morning sunlight and cool evenings of the Texas High Plains.
