Sitting on the banks of the river Lossie near the town of Elgin, Glenlossie Distillery has been producing whisky since 1876. Rarely seen as a single malt, its whisky is prized by Scotland's blenders. This 1997 vintage has a gentle oily character – sweet grain and citrus peel lead with a complex fruit salad palate; sweet then drying. A subtle and complex whisky with real depth. Matured in ex-bourbon casks and bottled at cask strength.
