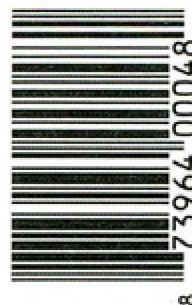

Manual harvest. Aged 18 months in French oak barrels. *Brilliant purple robe. Rich, fruity nose of blueberries, black currants and elder tree. Intense, full-bodied palate with concentrated flavors and lovely tannins in the grand Pauillac tradition. A velvety beauty.*

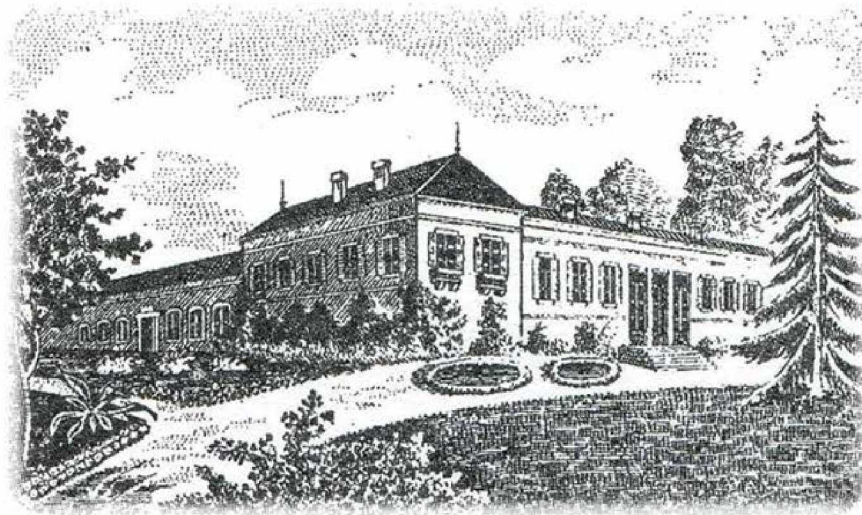
