Vinification

Grapes arrived by daybreak; sorted by bunch and by berry; separated into individual ferments; 0% to 50% whole clusters; cold soak for 5-6 days; native ferment; punched down daily 1-3 times; 12-16 days on skins; gently basket pressed; fed by gravity to French oak barrels; 60% new oak; aged 11 months; gentle filtration and fining.

The geography and various elevations of our site, ultimately forge the expression our wines. This flavorful and vibrant Estate Red Blend incorporates the diversity of varietals and clones planted on our estate, with a nod to the classic wines of Cotes du Rhone.
