O Porto LBV é um vinho de uma só colheita e todas as suas uvas provêm de vinhas velhas e são pisadas a pé e fermentadas em lagares de granito. Nós seleccionamos os vinhos com grande complexidade aromática e capacidade de envelhecer em cascos velhos de Vinho do Porto, mantendo ainda a sua estrutura, aromas e vivacidade. O nosso LBV não é filtrado de forma a permitir um excelente envelhecimento em garrafa.

*LBV Port is a wine of a single harvest. All grapes come from old vineyards and are foot-crushed and fermented in granite stone lagares. We select the wines that show aromatic complexity with capacity to age in old Port Wine casks, whilst still maintaining their structure, aromas and freshness. Our LBV is unfiltered in order to allow for an excellent ageing in bottle.*

Le Porto LBV est un vin d'un seul millésime dont ses raisins proviennent de vieilles vignes, qui sont soigneusement foulés à pieds et fermentés dans des lagares en granite. Nous sélectionnons les vins qui présentent une complexité d'arômes et capacité de vieillissement, dans des vieux fûts de vin de Porto, tout en maintenant sa structure, arômes, et vivacité. Notre LBV n'est pas filtré afin de garantir un très bon vieillissement en bouteille.
