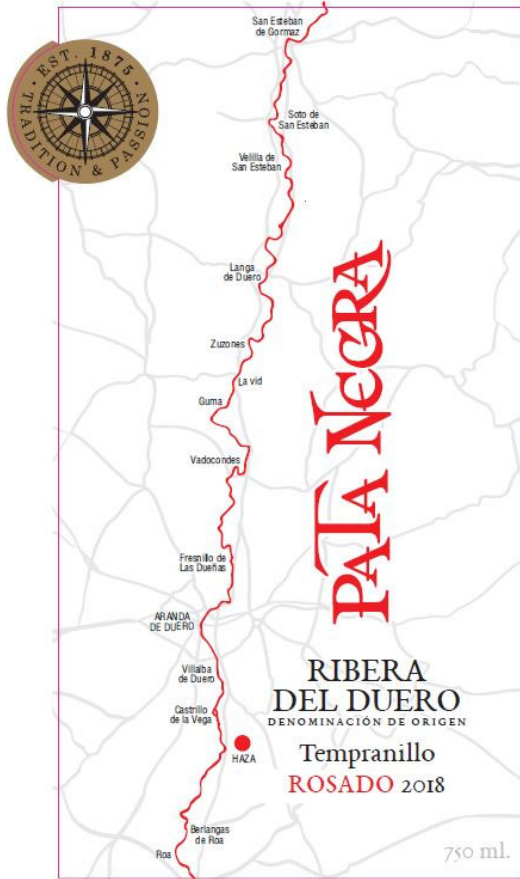

We select the grapes at their optimal point of ripeness to elaborate the wine Pata Negra Ribera del Duero, with pink tones and elegantly combined aromas of strawberries and raspberries, slightly milky. The result is a lively, fresh and fruity wine.
