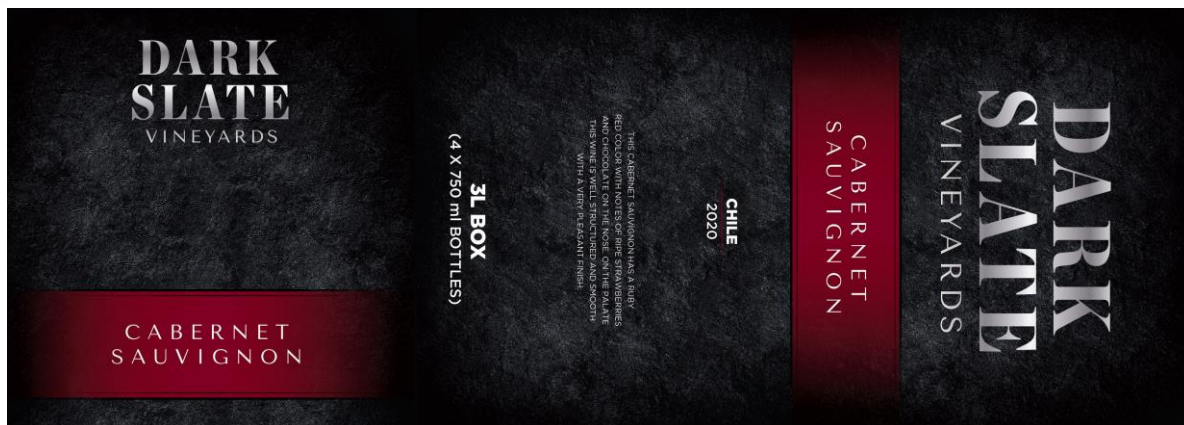

OPENING INSTRUCTIONS:



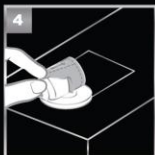
1 Lay box flat with box directions facing you. Press in the perforated circle (Tab A) and remove.



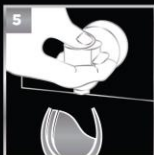
2 Lift the perforated flap (Tab B). Pull out the spout and slide it into the circle cutaway.



3 Push the flap (Tab B) down to lock the spout in place.



4 Tear off the tamper-proof seal and stand the box upright.



5 Pour by holding up the winged piston.



6 NO REFRIGERATION REQUIRED
Store in a cool dry place at room temperature. Once opened, refrigeration is not required.
