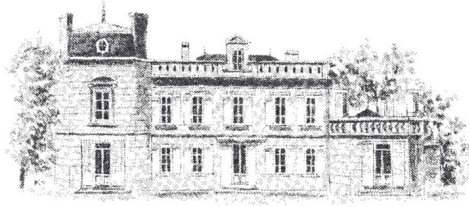

Ils peuvent être appréciés dans leur jeunesse, mais la complexité du fruit se révélera encore mieux à l'issue d'une dizaine d'années de vieillissement...

The foundations of a 2nd - 3rd century Gallo-Roman villa, found under part of the Château Mazeyres vineyard, indicate the ancient origins of the estate. The wine owes its complexity to the varied soil types in the 25,5 hectare vineyard. Château Mazeyres is smooth and rich as well as fine and elegant. The wine is enjoyable young but acquires a more complex character after a decade of ageing. Wine produced from a certified farm practising sustainable agriculture.
